Manuscripts should be submitted in electronic format only. To submit your paper, please log in *Kybernetika publishing system* and upload the manuscript in PDF format. The person submitting the paper will be referred to as the corresponding author.

By submitting a manuscript to Kybernetika the author declares that the paper has not been published or simultaneously submitted for publication elsewhere.

2.1. References

References should be cited within the text either by numerals in brackets or by author(s) followed by the respective numeral in brackets. References should be listed in alphabetical order. The following reference style should be used:

2.1.1. Journal article

Author(s): Title of paper. Title of the journal (abbreviated in accordance with Math. Reviews), volume, year of publication in brackets, inclusive pagination.
For an example see [3].

DOI:

2.1.2. Books, research reports and proceedings

Author(s): Title of book. Edition (if other than first). Publisher's name, place and year of publication.

For an example see [1].

2.1.3. Paper in a bound collection

Author(s): Title of paper. In: Title of collection, editor name(s) (in brackets), publisher's name, place and year of publication, inclusive pagination.

For an example, see [5].

2.2. Figures

Figures (charts and diagrams) should be in the EPS, PDF or JPG format or originated in TeX. Note that *Kybernetika* is not printed in color, so please keep in mind that pictures should be readily recognizable in the black and white version.

Tables and algorithms are not considered to be figures and should not be treated as such.
